- To educate people with disabilities about their voting rights and responsibilities – SABE GoVoter Toolkit Distance Training Webinars
- To provide technical assistance to improve voting experiences - Survey Findings
- To support the partnerships of P&As and Self Advocacy Groups – T/TA

The Ultimate Goal of the SABE GoVoter Project

"Increase the number of informed voters by improving education and accessibility."



#### **SABE GoVoter Toolkit Training**

- Since 2014, 20 webinar trainings on the GoVoter Toolkit
- P&As and Self Advocacy groups must submit a joint letter to participate in this training

- Voting problems and solutions
- Added a quiz:
  - Who is the governor?



- Who is the Lieutenant governor?
- Who is in charge of voting in the state?
- Who is running for president of the U.S.?

#### Ohio's SABE GoVoter Training Recommendations

- DRO will partner with self advocates in planning and implementing future vote trainings
- Use the Candidates Debate and Quiz (very interactive and fun)
- Produce a state specific video on partnering

#### Ohio's SABE GoVoter Training Recommendations (Continued)

- Increased civic engagement by participants after the training:
  - visited local boards of election
  - practiced voting equipment
  - served as poll workers

 The importance of self advocates completing the SABE GoVoter Experience survey to increase the number collected


 2018 survey Ohio collected the second highest number of surveys (389)

#1 problem, was not enough accessible parking	9 out of 10 voters felt that they voted the way they wanted	4 out of 10 voters voted at their polling location	6 out of 10 voters voted by themselves
9 out of 10 voters had no problem voting	1 out of 10 voters live in an institution	2 out of 10 voters have court appointed guardians	6 out of 10 voters did not know who to call if voting problem

#### 2018 SABE GoVoter Experience Survey Improvements

- Hard copy was made available for group meetings and mailed to key stakeholders
- Advertised on various types social media sites
- **NEW** Survey available in Spanish
- NEW Questions on Guardianship
- 1171 surveys collected (3 in Spanish)

#### Plans for 2020 Survey

#### **SABE GoVoter Advisory Committee Activities**

- Looking closely at questions in 2018 Survey
- Suggesting New questions for 2020 Survey
- For example: "Does your state have Supported Decision-Making as an option to Guardianship?"
  \_Yes \_\_No \_\_State working on legislation
- Translating survey into other languages beside Spanish?
