#### What is assisted living?

- No nationally definition
- As a term, first used by a movement to create an alternative to nursing homes in the 1980s Oregon
- One branch of the movement focused on enriching housing with services, another branch on making a health care setting more homelike
- The National Center for Assisted Living (NCLA) is "is the assisted living voice of the <u>American Health Care Association</u> (AHCA)."

#### NCAL's Principles for Assisted Living

- Serves primarily elderly people and individuals with disabilities.
- "Assisted living is more than a physical setting it embraces a philosophy of care."
- Provide assistance with activities of daily living and residents' healthrelated needs.
- Strive to meet the social, emotional, cultural, intellectual, and spiritual well-being of residents.
- Also known as: residential care, personal care, adult congregate care, boarding homes, and domiciliary care.

## Facts and Figures (From NCAL)

- There are approximately 28,900 assisted living communities with nearly 1 million licensed beds in the United States today. The average number of licensed beds in an assisted living community is 33.
- 8.6% Northeast, 22.6% Midwest, 28.0% South, 40.8% West
- 56% chain affiliated (2 or more), 42% independently owned
- **14.3%** have a dementia care unit, wing or floor designated, **8.7%** only serve adults with dementia

## Typical Services (NCAL)

- 24-hour supervision and assistance
- exercise, health and wellness programs
- housekeeping and maintenance
- meals and dining services
- medication management or assistance
- personal care services (such as Activities of Daily Living [ADLs])
- transportation

#### Residents (NCAL)

- 811,500\* residents, 71% women, 29% men
- 7% are 64 and under, 11% are 65-74, 30% are 75-84, 52% are 85+
- 64% need help bathing, 57% with walking, 48% dressing, 40% toileting, 29% bed transfer, 19% eating
- Median stay ~ 22 months, ~ 60% go to a skilled nursing center.

\*1.4 – 1.5 million in nursing homes

#### Workforce (NCAL)

- 453,000 employees
- 20% of nursing related and social work employed in long term care
- Breakdown:
  - 83.3% aide
  - 9.9% licensed practical or vocational nurse
  - 6.1% registered nurse
  - 0.8% social worker

## What does it cost annually? (Genworth 2019)

## Who pays?

- Private pay (e.g., long term care insurance, personal finances)
- Medicare does NOT cover assisted living, although most ALF residents are Medicare beneficiaries.
- 16.5% (~1/6) of ALF residents rely on a state Medicaid program
  - Medicaid state plan authorities,
  - § 1915(c) HCBS waiver,
  - concurrent § 1915(b) managed care waiver, or
  - §1115 research or demonstration programs.
- Medicaid does not pay for the room and board costs, only the personal care and supportive services.

- The setting is integrated in and supports full access of individuals receiving Medicaid HCBS to the greater community,
  - including opportunities to seek employment and work in competitive integrated settings, engage in community life, control personal resources, and receive services in the community, to the same degree of access as individuals not receiving Medicaid HCBS.

# Are ALF's discriminating against people with disabilities?

- "Assisted living facilities are ideal for seniors who are fairly independent but require assistance with daily activities, such as bathing, cooking, shopping, etc. An assisted home is a great first transition for your loved one if they have never lived outside of their own home."

#### Mental illness

- *H.O.P.E., Inc. v. Eden Mgmt. LLC,* No. 13-CV-7391, 2017 WL 4339824 (N.D. III. Sept. 29, 2017)
- Medicaid HBCS Waiver Supported Living Program
- Targeted to a) those under 64 with physical disabilities
  b) those 65 and older
- Prohibited admission to those with serious and pervasive mental illness and those with mental illness; SLF's by report and upon testing denied applications to anyone with a whiff of mental health diagnosis or asked to cover it up
- Brought case under FHA, ADA, and 504, won against MTD (above)
- Comprehensive settlement, with monitoring and enforcement, \$900,000 attorneys' fees from state, damages from SLFs

#### Harassment

#### Brief (PDF) and Opinion (PDF)

Lesbian resident of community for older adults alleged that she suffered severe and pervasive harassment from other residents, as required to state hostile housing environment claim against community's operator under Fair Housing Act (FHA); for 15 months, resident was allegedly bombarded with threats, slurs, derisive comments about her family, taunts about a deadly massacre, physical violence, and spit.

<u>Wetzel v. Glen St. Andrew Living Cmty., LLC</u>, 901 F.3d 856 (7th Cir. 2018), <u>cert. dismissed sub nom.</u> <u>Glen St. Andrew Living Com. v. Wetzel</u>, 139 S. Ct. 1249, 203 L. Ed. 2d 269 (2019)

#### Resident needs and ALF Services

- Can resident bring in their own services?
  - more hours of same type of care
  - different type of care
- Ability to meet needs of resident
  - Admission
  - Termination
  - Change in level of care
- Bell and Herriot cases

- Permission to leave, need "responsible person"
- Curfew

#### Landlord and Tenant Law

 Look to state Landlord and Tenant law as a source of rights (in addition to assisted living resident rights or regulatory scheme in your state).

*Ryan v. Mary Ann Morse Healthcare,* Supreme Judicial Ct., Mass. SJC-12708 12/5/2019 AARP's <u>Amicus Brief</u> (PDF) and <u>Decision</u> (PDF)

The SJC held that the ALR statute incorporated the Landlord-Tenant Security Deposit Law. As a result, ALRs may no longer charge an upfront general community fee like the \$2,800 fee at issue in this case. ALRs can still charge an upfront fee for the distinctive assisted living services not applicable to traditional landlord-tenant relationships, such as initial assessments of residents to determine their suitability for placement in an assisted living facility.
